### 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions:** Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

## 7. HANDLING AND STORAGE

**REPRODUCTIVE TOXICITY:** Imidacloprid caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Imidacloprid is related to parental toxicity.

## 12. ECOLOGICAL INFORMATION

This pesticide is highly toxic to aquatic invertebrates and bees exposed to direct treatment or residues on blooming crops/plants or weeds. This chemical demonstrates the properties and characteristics associated with chemicals detected in ground water.
