#### 4. FIRST AID MEASURES

#### 5. FIREFIGHTING MEASURES

#### 6. ACCIDENTAL RELEASE MEASURES

Clean up spills immediately observing the precautions in Section 8 of this SDS. Isolate the hazard area and keep unnecessary and unprotected personnel from entering. In case of spill on floor or paved surfaces, dike to contain spill and absorb with an absorbent such as clay, sand or soil if product cannot be recovered and used according to label. Prevent material from contaminating soil or from entering sewage and drainage systems and bodies of water. Clean contaminated floors and objects thoroughly with water and detergents observing all environmental regulations.

#### 7. HANDLING AND STORAGE
