4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain or soil. Contain contaminated water.

Spill Cleanup: Clean up spill immediately. **If spill is on land:** Use a wet sweeping compound or water to prevent dust formation. Sweep up and shovel into suitable containers for disposal. Clean and neutralize spill area, tools and equipment by washing with bleach water and soap. Absorb rinsate and add to the collected waste. Waste must be classified and labeled prior to recycling or disposal. Dispose of waste as indicated in Section 13. **If spill is in water:** Stop the source of the release. 7. HANDLING AND STORAGE

CHRONIC TOXICITY: Prolonged exposure to sulfentrazone caused decreased hemoglobin content and hematocrit, and increased spleen weight and splenic extramedullary hematopoiesis at high doses in animals. Formulation may cause damage to organs through prolonged or repeated exposure.

MUTAGENIC TOXICITY: No evidence of mutagenic effects for the active ingredients.

REPRODUCTIVE TOXICITY: No evidence of fertility or reproductive effects for the active ingredients.

TERATOGENICITY: Evidence of teratogenic effects for the sulfentrazone component in animal studies.
