4. First-aid measures

Inhalation

Suitable extinguishing media

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Take precautionary measures against static discharge. Use only non-sparking tools. This product is miscible in water. Prevent product from entering drains.

Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Following product recovery, flush area with water.
