4. First-aid measures

Germ cell mutagenicity There have been some positive and some negative studies, but the weight of evidence is that 2,4-D is not mutagenic.

Carcinogenicity The International Agency for Research on Cancer (IARC) lists exposure to chlorophenoxy herbicides as a class 2B carcinogen, the category for limited evidence for carcinogenicity in humans. However, more current 2,4-D lifetime feeding studies in rats and mice did not show carcinogenic potential. The U.S. EPA has given 2,4-D a Class D classification (not classifiable as to human carcinogenicity).
