This pesticide is extremely toxic to fish and aquatic invertebrates. Do not allow this product to enter or run off into storm drains, drainage ditches, gutters. **Persistence and degradability**

Not readily biodegradable.

: Bifenthrin degrades slowly in soil, the rate being influenced by soil characteristics; it is also stable in the aquatic environment. Bifenthrin, present at a concentration of 4.5 mg/kg and incubated for 24 months, was very stable to biodegradation in one soil (red brown earth: pH 7.1, 1.2% organic carbon, 59.1% sand, 28.3% silt, 10.5% clay) and two bedding materials (sand-dolomite (pH 9.2, 0.1% organic carbon, 80.2% sand) and quarry sand (pH 9.6, 0.2% organic carbon, 55.0% sand)). Degradation rate constants were 5.2X10<sup>-4</sup>, 4.9X10<sup>-4</sup>, and 5.0X10<sup>-4</sup> /day corresponding to half-lives of 1332, 1410, and 1386 days, respectively. Soil moisture had little effect on the rate of biodegradation.
