4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

GENERAL HAZARD: Toxic fumes may be emitted in a fire situation.

EXTINGUISHING MEDIA: Foam, dry chemical, carbon dioxide, water spray or fog.

EXPLOSION HAZARDS: No specific explosion hazards are identified or expected. Always fight fire with the implication that other volatile substances may be present.

FIRE FIGHTING PROCEDURES: Evacuate area and fight fire upwind a safe distance to avoid hazardous vapors and decomposition products. Foam or dry chemical fire extinguishing systems are perferred to prevent environmental damage from excessive water runoff.

7. HANDLING AND STORAGE


