#### Most important symptoms and effects

**Symptoms** May cause nose and throat irritation, with possible central nervous system effects. May

cause gastrointestinal irritation, nausea, diarrhea, and vomiting. Liquid ingestion may result in vomiting; aspiration of liquid into the lungs must be avoided as liquid contact with the

lungs can result in chemical pneumonitis and pulmonary edema/hemorrhage.

#### Indication of any immediate medical attention and special treatment needed

**Notes to Physician**Treat symptomatically. This product contains an organophosphate that inhibits

cholinesterase. If exposed, plasma and red blood cell cholinesterase test may indicate significance of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as 2-PAM/protopam, may be therapeutic if used early; however, use only in conjunction with atropine. In case of severe acute poisoning, use antidote immediately after establishing an open airway and respiration. Contains petroleum

distillate. Vomiting may induce aspiration pneumonia.
