4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice: Get medical attention if symptoms occur.

5. FIRE FIGHTING MEASURES

5.1 EXTINGUISHING MEDIA:

Suitable Extinguishing Media: Non-flammable. Material will not burn. Use extinguishing media suitable for surrounding materials. Foam, carbon dioxide (CO₂), dry powder, water spray. Do not use water jet as this will spread the fire.

5.2 SPECIAL HAZARDS ARISING FROM THE SUBSTANCE OR MIXTURE:

Specific Hazards During Firefighting: In a fire or if heated, a pressure increase will occur and the container may burst. Apply water from a safe distance to cool container and protect surrounding area.

5.3 SPECIAL PROTECTIVE EQUIPMENT AND PRECAUTIONS FOR FIREFIGHTERS

Special Protective Equipment for Firefighters: Self-contained breathing apparatus and full protective gear should be worn in fighting large fires involving chemicals. Use water spray to keep fire exposed containers cool. Keep people away. Isolate fire and deny unnecessary entry.

6. ACCIDENTAL RELEASE MEASURES

6.1 PERSONAL PRECAUTIONS, PROTECTIVE EQUIPMENT AND EMERGENCY PROCEDURES

Personal Precautions: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Do not breathe vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment.

6.2 ENVIRONMENTAL PRECAUTIONS

Environmental Precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN-UP

Methods for Clean-Up: Large Spills: Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13).
Small Spills: Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:

Advice on Safe Handling: Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous.

7.2 CONDITIONS FOR SAFE STORAGE:

Requirements for Storage Areas and Containers: Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Store locked up. Separate from acids. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.
