4. FIRST AID MEASURES

4.1 Description of First Aid Measures

General Advice: Eye contact may cause irritation. Repeated or prolonged skin contact may cause irritation. Ingestion may irritate the gastrointestinal tract.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferable by mouth-to-mouth, if possible. Call a poison control center or doctor for treatment advice.

Symptoms: Harmful if swallowed. Risk of irritation to eyes. Skin irritation. Respiratory tract irritation.

6. ACCIDENTAL RELEASE MEASURES

6.1 PERSONAL PRECAUTIONS, PROTECTIVE EQUIPMENT AND EMERGENCY PROCEDURES

Personal Precautions: Avoid inhalation of vapors and spray mist and contact with skin and eyes. Ensure adequate ventilation. Wear suitable protective clothing.

6.2 ENVIRONMENTAL PRECAUTIONS

Environmental Precautions: Prevent further leakage or spillage if safe to do so. Do not contaminate water. Do not allow to enter drains, sewers, or watercourses.

6.3 METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN-UP

Methods for Clean-Up: Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. After removal flush contaminated area thoroughly with water.
Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to Remove residual contamination.
Never return spills to original containers for re-use.

7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:

Advice on Safe Handling: Avoid inhalation of vapors / spray and contact with eyes, skin and clothing. Do not breathe mist or vapor. Wear personal protective equipment. Do not use in areas without adequate ventilation. Avoid prolonged exposure. Wash thoroughly after handling. Do not empty into drains. Handle and open container with care. Use care in handling/storage. Wash before eating, drinking and/or smoking.

8.2 EXPOSURE CONTROLS:

Engineering Measures
