4. FIRST AID MEASURES

7. HANDLING AND STORAGE

Precautions to be Taken in Handling: Keep away from heat, sparks and flame. Keep container sealed when not in use. Safety goggles with full-face shield and eyewash recommended. USDA-accepted nitrile (CFR-20) or neoprene rubber (CFR-21) recommended. Wear appropriate clothing to prevent repeated or prolonged skin contact. Use only with adequate mechanical exhaust ventilation.

Precautions to be Taken in Storage: Product should be stored in a dry place at temperatures between 46 and 100°F. Ethylene oxide may collect in container head space. Although concentrations are expected to remain below established exposure limits, provide adequate ventilation when accessing or working with open containers and tanks.

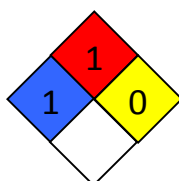
