SECTION 4: FIRST AID MEASURES

IF POISONING IS SUSPECTED, immediately contact the poison information centre, doctor or nearest hospital. SECTION 5: FIRE FIGHTING MEASURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment and Emergency Procedures: Control the spill at its source. Clean up spills immediately, observing precautions outlines in Sections 7 and 8. Use adequate ventilation and equipment and wear clothing as described in Section 8 and/or the product label.

Environmental Precautions: Contain the spill to prevent from spreading or contaminating soil or from entering sewage and drainage systems or any body of water. Spillages or uncontrolled discharges into watercourses must be reported to the appropriate regulatory body.

Methods and Materials for Containment and Cleaning Up: Scoop or sweep up material and place into a disposal container. Wash area with detergent and water. Pick up wash liquid with additional absorbent and place into a compatible disposal container. On soils, skim off the upper contaminated layer and collect for disposal. Once all material is cleaned up and placed in a disposal container, seal container and arrange for disposal.
