Spirotetramat caused male reproductive toxicity in the presence of general toxicity in the rat at very high experimental dose levels. There were no effects on male fertility in mice and dogs. The reproductive toxicity seen with Spirotetramat is due to an overwhelmed elimination capacity at high doses. The high
