Skin contact

Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice. Wash face, hands and any exposed skin thoroughly after

handling. Take off contaminated clothing. Seek immediate medical attention/advice. Wash off immediately with plenty of water for at least 15 minutes. Remove and wash contaminated clothing before re-use.

Inhalation

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a physician or poison control center immediately.
