Clothianidin caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Clothianidin is related to parental toxicity. Beta-Cyfluthrin caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Beta-Cyfluthrin is related to parental toxicity. Beta-Cyfluthrin is classified as reproductive toxicant in category for effects via lactation, mainly based on coarse tremors in pups of the 2-generation study. As a mechanism study for ocular effects in rat pups suggested possible adverse effect via milk, the active ingredient was classified with an additional category for effects on or via lactation.
