4. FIRST AID MEASURES

5. FIREFIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Isolate area and keep unnecessary and un-protected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.
