## 4. FIRST AID MEASURES

It is expected to be slightly irritating to the skin and minimally irritating to the eyes. Treatment is otherwise controlled by removal of exposure followed by symptomatic and supportive care. Contains petroleum distillate. Vomiting may cause aspiration pneumonia.

### 5. FIREFIGHTING MEASURES

## **6. ACCIDENTAL RELEASE MEASURES**

**Personal Precautions:** Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.
