**SECTION 2 - HAZARDS IDENTIFICATION SUMMARY**

(As defined by OSHA Hazard Communication Standard, 29 CFR 1910.1200)

Clear light amber liquid with a pungent odor.

**HEALTH HAZARDS:** DANGER. Corrosive. Causes irreversible eye damage if not treated promptly.

**PHYSICAL HAZARDS:** May release toxic fumes if burned.

**ENVIRONMENTAL HAZARDS:** May be toxic to fish, aquatic invertebrates and non-target plants.

Use of this chemical in areas where soils are permeable, and the water table is shallow, may result in groundwater contamination.

**SECTION 4 - FIRST MEASURES**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**STORAGE:** Do not store this product near fertilizers, seeds, insecticides, or fungicides. Reclose all partially used containers by thoroughly tightening screw cap. **SECTION 12 - ECOLOGICAL INFORMATION**

**ENVIRONMENTAL SUMMARY:** This pesticide may be toxic to fish and aquatic invertebrates. For terrestrial uses: Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment washwaters or rinsate. Apply this product only as directed on label.
