#### **SECTION 4: FIRST AID MEASURES**

## **SECTION 5: FIRE FIGHTING MEASURES**

#### SECTION 6: ACCIDENTAL RELEASE MEASURES

Methods and Materials for Containment and Cleaning Up: Pump or scoop large amounts of liquid into a disposable container. Absorb remaining liquid or smaller spills with clay, sand or vermiculite.
