## 2. HAZARDS IDENTIFICATION SUMMARY

**KEEP OUT OF REACH OF CHILDREN – CAUTION –** Causes eye irritation. Harmful if inhaled. Avoid contact with eyes or clothing. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Prolonged or frequently repeated skin contact while handling this material may cause allergic reaction in some individuals. Avoid contact with skin, eyes, open cuts, or sores. In case of contact, flush with water. Get medical attention for eyes. The fertilizer in this product is derived from Methylene Ureas, Polymer Coated Sulfur Coated Urea, Urea, Monoammonium Phosphate, and Sulfate of Potash. Nausea and vomiting could be expected upon large dose ingestion. The acute ingestive effects are described as nausea, chills, and diarrhea. Eye or skin contact with these products could cause irritation (particularly in sensitive persons), and respiratory irritation could be expected from the unprotected inhalation of fertilizer dusts. Product users should avoid prolonged or repeated skin contact by wearing impervious gloves, long sleeve shirt, long pants, socks and rubber boots. Goggles for eye protection are recommended. Wash thoroughly after handling and using this product.

## 4. FIRST AID MEASURES
