2. HAZARDS IDENTIFICATION SUMMARY

4. FIRST AID MEASURES

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have a person sip a glass of water if able to do so. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

EXTINGUISHING MEDIA: Considered non-combustible, use medium appropriate to surrounding fire. Dry chemical, carbon dioxide, foam, water spray or fog.

6. ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

Avoid breathing dusts. Sweep up dry spills immediately and transfer to suitable containers for possible land application according to label use or for disposal. Check local, state and federal regulations for proper disposal.

CAUTION: Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

7. HANDLING AND STORAGE

HANDLING: Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

STORAGE: Store in a cool, dry, place and in such a manner as to prevent cross-contamination with other pesticides, fertilizers, food and feed. Store in original container and out of reach of children, preferably in a locked storage area. Do not contaminate water, food, or feed by storage or disposal.
