### 4. FIRST AID MEASURES

#### Description of first aid measures

<b>General advice</b>	Get medical attention if symptoms occur.
<b>Eye contact</b>	Hold eyelids apart and flush eyes with plenty of water for at least 15 minutes. Get medical attention. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

### 6. ACCIDENTAL RELEASE MEASURES

#### Personal precautions, protective equipment and emergency procedures

Clean contaminated surface thoroughly. Prevent product from entering drains. Dam up. After cleaning, flush away traces with water.
