Assessment toxicity to reproduction

Beta-Cyfluthrin caused reproduction toxicity in a two-generation study in rats only at dose levels also toxic to the parent animals. The reproduction toxicity seen with Beta-Cyfluthrin is related to parental

toxicity. Beta-Cyfluthrin is classified as reproductive toxicant in category for effects via lactation, mainly based on coarse tremors in pups of the 2-generation study. As a mechanism study for ocular effects in rat pups suggested possible adverse effect via milk, the active ingredient was classified with an additional category for effects on or via lactation.

Assessment developmental toxicity

Beta-Cyfluthrin caused developmental toxicity only at dose levels toxic to the dams. The developmental effects seen with Beta-Cyfluthrin are related to maternal toxicity.
