Reproductive/Developmental Effects

Chronic/Subchronic Toxicity Studies

Potassium salt of glyphosate: N-(phosphonomethyl) glycine: Rat subchronic 90-day study - NOEL of 5000 ppm (410 - 440 mg/kg). Body weight reduction, clinical chemistry changes.
