4. FIRST AID MEASURES

If in Eyes: Hold eye open and rinse slowly and gently with water for several minutes. Remove contact lenses, if present, continue rinsing eye. Call a poison control center or doctor for treatment advice.

If Swallowed: Call a poison control center or doctor for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If Inhaled: Move person to fresh air. If breathing is difficult, administer oxygen. If symptoms develop, get medical advice.

If on Skin or Clothing: Take off contaminated clothing. Rinse skin with plenty of water for several minutes. Call a poison control center or doctor for treatment advice.

Most important symptoms/effects, acute and delayed: May cause moderate eye irritation. May cause slight skin and respiratory tract irritation. May damage the unborn child by ingestion.

Indication of immediate medical attention and special treatment needed, if necessary: Immediate medical attention should not be required.

5. FIRE FIGHTING MEASURES

Extinguishing Media: Recommended for large fires: foam or water spray. Recommended for small fires: dry chemical or carbon dioxide.

Special Fire Fighting Procedures: Firefighters should wear NIOSH approved self-contained breathing apparatus and full fire-fighting turn out gear. Dike area to prevent runoff and contamination of water sources. Dispose of fire control water later.

Unusual Fire and Explosion Hazards: Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source, is a potential dust explosion hazard. If water is used to fight fire, contain runoff, using dikes to prevent contamination of water supplies. Dispose of fire control water later. **Hazardous Decomposition Materials (Under Fire Conditions):** May produce gases such as oxides of carbon, hydrogen and nitrogen.

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Wear appropriate protective gear for the situation. See Personal Protection information in Section 8.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

Methods for Containment: Dike spill using absorbent or impervious materials such as earth, sand or clay. Collect and contain contaminated absorbent and dike material for disposal.

Methods for Cleanup and Disposal: Pump any free liquid into an appropriate closed container. Collect washings for disposal. Decontaminate tools and equipment following cleanup. See Section 13. DISPOSAL CONSIDERATIONS for more information.

7. HANDLING AND STORAGE

Handling:

Avoid contact with eyes or clothing. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove Personal Protective Equipment (PPE) immediately after handling this product. Wash outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

Storage:

Store above 32° F (0° C) and below 75°F (24°C). Keep containers tightly closed when not in use.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

Engineering Controls:

Where engineering controls are indicated by specific use conditions or a potential for excessive exposure, use local exhaust ventilation at the point of generation.

Personal Protective Equipment:

Eye/Face Protection: To avoid contact with eyes, wear chemical goggles or shielded safety glasses. Ar emergency eyewash should be readily accessible to the work area.

Skin Protection: To avoid contact with skin, wear long pants, long-sleeved shirt, socks, shoes and chemical-resistant gloves, such as barrier laminate; butyl, nitrile or neoprene rubber; polyvinyl chloride; or viton. An emergency shower should be readily accessible to the work area.

11. TOXICOLOGICAL INFORMATION

Skin Sensitization: Not a contact sensitizer in guinea pigs following repeated skin exposure.

Subchronic (Target Organ) Effects: Repeated overexposure to 6-benzylaminopurine may cause decreased body weight gains related to decrease in food consumption. In teratogenicity studies in rabbits, no maternal or fetal toxicity, or other adverse effects to the fetus were noted following repeated dosages (up to 1000 mg/kg/day) of Gibberellins A4/A7.

Carcinogenicity / Chronic Health Effects: 6-benzylaminopurine did not cause cancer in laboratory animals. Gibberellins A4/A7.

Reproductive Toxicity: In studies with animals, 6-benzylaminopurine did not cause reproductive toxicity. No data available for Gibberellins A4/A7.

Developmental Toxicity: In animal studies with 6-benzylaminopurine, developmental effects were observed at doses that were also toxic to the maternal animal. No data available for Gibberellins A4/A7. N-methyl-pyrrolidone has shown to have negative effects on developing fetuses in animal studies.

Genotoxicity: Tests with 6-benzylaminopurine have shown no evidence of mutagenicity. Tests with Gibberellins A4/A7 show no evidence of mutagenicity.

Assessment Carcinogenicity: None listed with ACGIH, IARC, NTP or OSHA.

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Handling and Disposal:

Nonrefillable Containers 5 Gallons or Less

Nonrefillable container. Do not reuse or refill this container. Offer for recycling if available. Triple rinse container (or equivalent) promptly after emptying.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Plastic containers are also disposable by incineration, or, if allowed by State and local authorities, by burning. If burned stay out of smoke.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure-rinsing nozzle in the side of

the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Refillable containers larger than 5 gallons

Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To clean the container before final disposal, empty the remaining contents from this container into application equipment or a mix tank. Fill the container about 10% full with water. Agitate vigorously or recirculate water with the pump for two minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times.
