



Section 4 : First Aid Measures

Section 7: Handling and Storage

Handling:

Information for safe handling: Prevent formation of aerosol.

Information about fire and explosion protection:

Protect against electrostatic charges.

Keep ignition sources away - Do not smoke.

Storage:
