### 4. First-aid measures

#### Inhalation

Move to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison center or doctor/physician for further treatment advice.

#### Skin contact

Remove contaminated clothing. Wash off immediately with plenty of water for at least 15 minutes. Call a physician or poison control center for treatment advice.

<b>Eye contact</b>	Immediately flush eyes with plenty of water for at least 15 minutes. Hold the eyelids apart during the flushing to ensure rinsing of the entire surface of the eyes and lids with water. ## 6. Accidental release measures

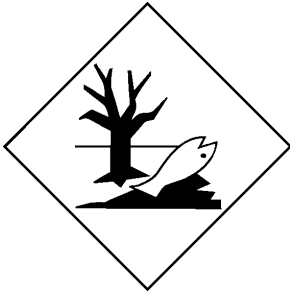
