### FIRST AID

**If In Eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. If eye irritation persists, get medical advice/attention.

**If Inhaled:** Move person to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. If you feel unwell, call a poison control center or physician for further treatment advice.

### GENERAL INFORMATION

**8Ball** is a drift reduction and water conditioning agent formulated specifically for XtendiMax® tank mixes to reduce off-target drift. **8Ball** imparts a neutral pH. **8Ball** can eliminate antagonism of the spray tank caused by hard water minerals such as calcium, iron and magnesium. The surfactant ingredient in **8Ball** improves spray droplet spreading and penetration into the targeted leaf surface. **8Ball** provides humectancy to spray droplets resulting in a slower drying time for enhanced uptake of active ingredients. **8Ball** can be used for a wide range of pesticide and nutrient spray mixtures when accompanying labels recommend water conditioners and spreader-wetter adjuvants.

### ENVIRONMENTAL HAZARDS

### MIXING

Prior to any pesticide application, all spray equipment must be thoroughly cleaned. Carefully observe all tank cleaning directions on the pesticide label. Do not mix **8Ball** with undiluted herbicides. Unless instructed otherwise by accompanying pesticide label instructions, fill spray tank 1/2 full with water, add **8Ball** first then continue filling tank. Add remaining pesticide or nutrient ingredients consistent with respective label directions.

### DIRECTIONS FOR USE

For use with herbicides registered for use for agriculture, forestry, and industrial, municipal, ornamental, right-of-way, turf and non-cropland.

Prior to using **8Ball**, the user or application advisor must have experience with the combination of active ingredients or must have conducted a phytotoxicity trial.

**8Ball** may be applied by ground, CDA or aerial spray equipment.

**Ground, Aerial, Water Conditioning:** Use 2 to 4 quarts per 100 gallons of spray mixture (0.5% v/v to 1.0% v/v) when used in place of ammonium sulfate.

**For Use As a Drift Reduction Agent for XtendiMax® Engenia® or FeXapan™ Tank Mixes:** Use 5 pints per 100 gallons in the spray mixture.

**For General Use As a Drift Reduction Agent:** Use 1 to 3 quarts per 100 gallons in the spray mixture.

**Do not use this product at a rate to exceed 1% v/v of finished spray tank mixture.**
