#### **IMPREGNATION RATES: DRY FERTILIZERS**

Improves fertilizer efficiency.

Recommended rate range is 1 to 4 gallons of **Accomplish**® per ton of dry fertilizer depending on makeup of dry fertilizer blend. Blends that contain both potassium and phosphate inputs will absorb more **Accomplish** than those made from a higher percentage of urea. Higher rates of impregnation are possible when fertilizer handling systems are capable of adding drying clay. Contact your Loveland Products representative for specific information.

#### PRE-BLENDING OR TANK MIXING RATES: LIQUID FERTILIZERS

If mixing with liquid fertilizer or herbicides, perform a Jar Test to assure compatibility with different mixtures of chemicals. It is typically recommended to mix in the following order: fertilizers, chemicals, water, and **Accomplish**. Do not mix with fungicides EXCEPT Azoxystrobin products. Liquid fertilizers in the pH range of 5 to 9 are compatible with **Accomplish**.

### **ACCOMPLISH® APPLICATION RATE PER ACRE**

**Starter or side dress:** 1 to 2 quarts per acre

Broadcast: 2 to 4 quarts per acre for Agricultural use. 3 to 6 ounces per 1000 sq. ft. on Turfgrass. 2 to 4 quarts per acre for ornamentals.

Apply 1 to 2 times per year.
