DIRECTIONS FOR USE

If the directions do not indicate a specific order of addition, **MVO PLUS 1** may be added any time after all solid materials have been added and completely dispersed. Preferably, add **MVO PLUS 1** last before the final addition of water.

In addition, the organosilicone surfactant increases spreading and wetting of the applied solution so that the active moves to and through the plant quickly.

Use **MVO PLUS 1** wherever a label calls for an MSO or MVO and allows or does not exclude the use of an organosilicone.
