GENERAL INFORMATION

Amino-Che Zinc is designed for use in a fertility program on food and fiber crops that have displayed deficiencies to zinc. It is recommended for use as an additive in liquid polyphosphate fertilizer, such as 10-34-0. **Amino-Che Zinc** is compatible with many herbicides and may be used as an additive in early-season herbicide application as permitted by herbicide labelling. **Amino-Che Zinc** is most effective when placed in the root zone during planting or moved into the soil by irrigation, tillage, or rainfall.

DIRECTIONS FOR USE

This product should be used on the basis of a soil and/or tissue analysis. Optimum rate of application will vary among fields, depending on soil pH, organic matter, crop and severity of zinc deficiency. For fertilizer application rates suitable for

your geographical area or the maximum allowable application rate per acre, consult a certified crop advisor or a trained agronomist.

Mixing Instructions: Add 1/3 to 1/2 of the liquid fertilizer to mix tank. Add correct amount of **Amino-Che Zinc**. Add remainder of fertilizer, then mix thoroughly with strong agitation. Other chemicals, if used, should be added after the fertilizer/ micronutrient mix has been prepared. **CAUTION:** Check compatibility with orthophosphate fertilizers and other chemicals prior to mixing.

SOIL APPLICATION: Apply **Amino-Che Zinc** in water or in combination with liquid fertilizer for pre-plant, starter or side dress applications. The most effective treatment of row crops is soil applications in a band at planting time or as a side dressing shortly after planting. For dry fertilizer applications use Winfield's granular micronutrients.

APPLICATION WITH IRRIGATION WATER: Pivot, Sprinkler, Overhead and Solid Set Irrigation: Apply within 2 weeks of planting and before flowering using 1 to 4 quarts per acre or the dosage rates and timing recommended by your State Agricultural Experiment Station, Extension Specialists or Winfield United Regional Agronomist. This product may be mixed with most liquid fertilizers or pesticides before injection. Use a back-flow check valve to prevent material from back siphoning into water system.
