Add 1 to 2 fluid ounces of ANTIFOAM per 100 gallons of spray mixture. For recirculating sprayers, add 4 fluid ounces per 100 gallons of spray mixture.

If foam has already occurred, add 6 fluid ounces of ANTIFOAM per 100 gallons of spray mixture.
