aquaFUSION® 20-0-0 is a blend of ammonium hydroxide, methylene urea and triazone formulated to provide a steady supply of plant available nitrogen. The methylene urea and triazone components are converted to plant available nitrogen by soil microbes, which is temperature dependent, resulting in increased nitrogen release as soil temperatures warm and crop demand for nitrogen increases.

aquaFUSION 20-0-0 should be used as part of a comprehensive Total Nutrition System® for optimizing plant growth, development, yield and quality. Consult your area Wilbur-Ellis representative for specific recommendations.
