Applications: AquaMark Liquid transforms pale, dirty or off-colored water to a sprakling blue. AquaMark Liquid may be used to color ornamental lakes, ponds, fountains and other contained bodies of water. This product should not be applied to streams, rivers, outflows, or water not completely controlled by the user. AquaMark Liquid may be applied to areas used for irrigation, but not for direct human consumption. Swimming and other recreation sports are approved during and following use of the product. Fish, waterfowl and animals are not harmed by normal use of this product.

Directions—Lake & Pond Colorant Application: Determine the volume of water to be treated, then consult the suggested use rate chart to determine the amount of colorant to use. If a darker or lighter color of water is desired, vary the rate accordingly. Pour from the container near the shoreline at several locations for best color coverage.

Directions—Aquatic Spray Pattern Indicator Application: AquaMark Liquid may be used as a spray pattern indicator to provide a temporary visual mark of control product applications on emerged aquatic weeds. Add AquaMark Liquid at the rate of 16 to 24 ounces per 100 gallons of spray solution. Applicator may vary the rate to achieve the desired color intensity. Application overspray may result in temporary coloration of the water.

Storage: Store in a cool, dry place. Store in original container. Keep container tightly closed. Do not reuse empty container.

Disposal: Do not contaminate water, food or feed by storage or disposal. Wastes may be disposed of on-site or at an approved waste disposal facility. Triple rinse (or equivalent) adding rinse water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities.
