#### **GENERAL INFORMATION**

ASCENSION® is a blend of water-conditioning agent and surfactant for use with various herbicides which recommend the use of UAN solution and a nonionic surfactant, specifically sulfonyl urea herbicides. The addition of nitrogen-based fertilizers (such as 28% N, or 10-34-0), or ammonium sulfate (AMS), are generally not required with ASCENSION.

#### NOT FOR AQUATIC USE.

#### **DIRECTIONS FOR USE**

Care must be taken when spraying sensitive crops.

REFER TO HERBICIDE LABEL FOR SPECIFIC CROP USE AND APPLICATION RATES.

Prior to use, read and follow all directions on this label and on the label of the herbicide being used. The herbicide manufacturer's label for specific usages and restrictions have precedence over the DIRECTIONS FOR USE referred to on this label.

#### MIXING

- 1. Fill spray tank half full of water and start agitation.
- 2. Add herbicides as directed by the label, while maintaining agitation.
- 3. Add ASCENSION last to the spray mixture and continue agitation or follow specific tank filling and mixing information provided on the herbicide label.

#### **USE RATES**

HERBICIDES: Use 2-4 quarts ASCENSION per 100 gallons spray mixture (0.5-1.0% v/v).

For spray water volumes below 5 gallons per acre, use 1–2 gallons ASCENSION per 100 gallons spray mixture (1-2% v/v).

#### STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

**PRODUCT STORAGE:** Store in original container only and keep tightly sealed. Store in closed storage area. **PRODUCT DISPOSAL:** Dispose of contents in accordance with all government regulations.
