FIRST AID

GENERAL INFORMATION

ATTITUDE™ is a water conditioner and acidifying agent to reduce the pH of a tank mix solution.

DIRECTIONS FOR USE

ATTITUDE should not be used with products that require a solution pH higher than 5, for example sulfonyl urea herbicides or copper-based fungicides. ATTITUDE can lessen performance of products containing significant amounts of carbonates. Do a jar test on all new tank mix combinations. It is advised that a phytotoxicity test be conducted by spraying a small section of the crop before widespread use. ATTITUDE can be applied by ground, aerial or CDA application.

NOTE: Not for aquatic use.

MIXING

ATTITUDE is compatible with TYPHOON® fungicide. Ensure all spray equipment have been thoroughly cleaned before use. Read the label of the tank mix partner(s) to be used with ATTITUDE for any mixing precautions. For tank mixing with TYPHOON, follow the TYPHOON label instructions for mixing and rates. For other tank mixes, fill the spray tank halfway and begin agitation. Add ATTITUDE to the water first, followed by other chemicals as directed by their respective labels. Do not mix ATTITUDE with undiluted pesticides. Spray equipment should be rinsed thoroughly after use.

RECOMMENDED RATES

Read the directions on the pesticide label to comply with pH requirements of the pesticide. To adjust the pH of the spray solution to within a range of 5 – 2.8, add 16 to 128 ounces of ATTITUDE per 100 gallons of spray solution (0.125 – 1% v/v) unless directed otherwise by tank mix partner label. Do not exceed a rate of 1% (v/v).

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. **STORAGE:** Store in original tightly closed container. Store away from incompatible materials. In the event of spillage or leakage, soak up the material with absorbent clay, sand, sawdust or other absorbent materials. **PRODUCT DISPOSAL:** Collect and reclaim or dispose in sealed containers at licensed waste disposal site. **CONTAINER DISPOSAL:** Triple rinse container and pour rinsate into spray tank. Do not reuse container. Recycling decontaminated containers is the best option of container disposal. Dispose of contents/container in accordance with local/national regulations.
