FIRST AID

Planting Window	Plant treated corn seed within 120 days of application
Proper Equipment & Handling	<ul style="list-style-type: none"> All crop seed is susceptible to damage from excess handling. Equipment must be designed to safely handle seed corn to minimize potential mechanical damage to seed germination and physical integrity. Recommended treater types include: <ul style="list-style-type: none"> Vertical chute treaters with adequate baffling to minimize vertical drops. Drum treaters <ul style="list-style-type: none"> Avoid excessive seed time in the drum to minimize mechanical handling. Centrifugal commercial batch treaters. Auger treaters of any type are NOT RECOMMENDED. Use seed ladders to minimize the vertical fall and hard surface impact of seed, including load-out into a "ProBox"-type container or seed tenders, to avoid seed damage from excessive vertical drop. If treated seed is being transferred to a closed container such as a "ProBox"-type container, leave the container top uncovered for 24 hours after treatment.
