TANK MIXES:

B Sure can be mixed with most liquid fertilizers or plant nutritional or protection products, including fertilizer mixtures that contain insecticides, herbicides, plant growth regulators and fungicides. B Sure may also be applied with all transplant solutions, dips and watering solutions. It is advised to conduct a compatibility test first, before applying this product in mixed formulations. If mixing with liquid fertilizers, it is recommended to mix in the following order: (1) water (2) fertilizer or chemicals (3) B Sure. DO NOT mix with concentrates.
