BENVIREO NSententials DRY 13-0-0 can be top-dressed or lightly incorporated. BENVIREO NSententials DRY 13-0-0 is recommended for use under sprinkler irrigation. Not recommended for use under drip irrigation if drip is the sole source of water. Consult your Wilbur-Ellis representative for specific use rates.
