**DIRECTIONS FOR USE**

**PLANTER BOX/HOPPER BOX APPLICATION**

The recommended application rate is one scoop (1 ounce) of BioWake™ for Peanut per 100 pounds of peanut seed (20 oz pouch treats 2000 pounds of seed). May be applied in conjunction with seed lubricant and other inoculants.

Appropriate amount of BioWake™ for Peanut per seed quantity should be dispersed evenly onto seed with appropriate equipment. If blended with seed lubricant, blended BioWake™ for Peanut and lubricant must be applied to seed within 7 days. Treated seed must be planted within 180 days.

**BioWake™ for Peanut can be applied in all planter types.**

No additional specific markers or distinguishing features of seed coating are needed.
