#### **GENERAL INFORMATION**

BLACKJACK® B 2.5% Boron 4-0-0 is formulated for the prevention or correction of boron deficiencies in plants and may be effectively used for both foliar and soil applications. BLACKJACK B 2.5% is non-phytotoxic when used as directed and is compatible with most pesticides and fertilizers.

BLACKJACK B 2.5% will be influenced by differences in varieties, soil and environmental conditions and should be applied under conditions of optimum plant growth. Optimum conditions are defined as adequate humidity. moderate temperatures and adequate soil moisture. Optimum conditions for most crops generally occur early morning or late evening hours.

CAUTION: Always check compatibility with other chemicals prior to use. Avoid drift to adjacent crops and do not overlap spray patterns. Do not mix with conventional calcium fertilizers.

CAUTION: Foliar application of BLACKJACK B 2.5% close to harvest may leave a brown residue on the harvestable portion of the crop. Rainfall, sprinkler irrigation or high humidity should alleviate this condition.

#### DIRECTIONS FOR USE

BLACKJACK B 2.5% can be applied to most vegetable and cucurbit crops, field and row crops, deciduous fruit and nut trees, grapes, berries, olives, avocados and citrus. BLACKJACK B 2.5% is designed for soil application and for foliar use. Apply directly to soils or inject through irrigation systems where water quality is satisfactory to maintain solubility. Foliar applications should be as a dilute spray. Application rates vary by crop or situation. Mixing with irrigation water for field storage is generally not recommended. Products blended with irrigation water should be used immediately and not stored for prolonged periods.

CONFIRM EXISTING BORON LEVELS IN PLANT TISSUE ANALYSIS PRIOR TO ANY APPLICATION.

#### FOLIAR APPLICATION RATES

VEGETABLES, FIELD AND ROW CROPS: Apply 1 pint to 4 quart acre in a minimum of 10 gallons of water per acre as a foliar spray. applied through center pivot irrigation systems. Repeat applications beneficial.

ORCHARDS & VINEYARDS, FRUIT CROPS: Apply 1 pint to 4 quarts per acre. Aerial applications use a minimum of 10 gallons of water per acre. Dilute or concentrate sprays use a minimum of 25 gallons of water per acre. Repeat applications may be beneficial.

NOTE: For all crops, the rate of water used should be sufficient for thorough coverage. Coverage is dependent on proper droplet size and pressure.

#### SOIL APPLICATION RATES

ALL CROPS: May be applied pre-plant, as a starter, side dress, fertigated, top dressed or banded to the soil. To apply alone, dilute with water to ensure uniform distribution. Use 1 pint to 8 guarts per acre. May be applied through all irrigation systems. Repeat applications may be beneficial.

TRANSPLANT WATER - ALL CROPS: Apply 1 to 4 quarts per acre in a minimum of 50 gallons solution.

#### **FERTIGATION APPLICATION RATES**

Drip irrigation, micro sprinklers, solid set and moving sprinklers. All crops: Use 1 to 8 guarts per acre per irrigation. Continue irrigation for a minimum of 2 hours after application to flush lines and to maximize nutrient distribution with drip and micro sprinkler.

APPLICATION THROUGH DRIP IRRIGATION - inject after irrigation filter.

#### **MIXING INSTRUCTIONS**

BLACKJACK B 2.5% disperses well in water, but for best results, mix as follows:

- 1. Partially fill tank with water or fertilizer and start agitation.
- 2. Add other nutrients or pesticides if compatible.
  - 3. Add **BLACKJACK B 2.5%** to circulating tank mix.
  - 4. Fill tank and agitate thoroughly.
