#### GENERAL INFORMATION

**BLACKJACK<sup>®</sup> Ca 7% Calcium 5-0-0** is formulated in a proprietary process for the prevention or correction of calcium deficiencies in plants and can be effectively used for both foliar and soil applications.

**CAUTION:** Always check compatibility with other products prior to use. Do not mix with conventional products containing the salts of heavy metals. Do not mix with conventional phosphorus based fertilizers.

**CAUTION:** Foliar application of **BLACKJACK Ca** close to harvest may leave a brown residue on the harvestable portion of the crop. Rainfall, sprinkler irrigation or high humidity should alleviate this condition.

#### DIRECTIONS FOR USE

**BLACKJACK Ca** can be applied to most vegetable and cucurbit crops, field and row crops, deciduous fruit and nut trees, grapes, berries, olives, avocados and citrus. **BLACKJACK Ca** is designed for soil application and for foliar use. Apply directly to soils or inject through irrigation systems where water quality is satisfactory to maintain solubility. Foliar applications should be as a dilute spray. Application rates vary by crop or situation. Mixing with irrigation water for field storage is generally not recommended. Products blended with irrigation water should be used immediately and not stored for prolonged periods.

**TURF:** Apply 3 to 6 ounces per 1,000 sq. ft. every 7 to 14 days or as needed. Apply in a minimum of 2 gallons spray solution per 1,000 sq. ft.

**LANDSCAPE:** Apply 0.5 to 2 gallons per 100 gallons of water. Apply as a soil solution at 1 to 2 gallons per 1,000 sq. ft. Volumes based on agronomic demands.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rains are expected. Apply this product only to your lawn/garden.

#### FOLIAR APPLICATION RATES

**FIELD AND ROW CROPS:** Apply 1 to 6 quarts per acre in a minimum of 10 gallons of water per acre. May be applied through center pivot irrigation systems. Repeat applications may be beneficial.

**VEGETABLE & FRUIT CROPS, ORCHARDS & VINEYARDS:** Apply 1 to 4 quarts per acre. In aerial applications use a minimum of 10 gallons of water per acre. In dilute or concentrate sprays use a minimum of 25 gallons of water per acre. Repeat applications may be beneficial.

#### SOIL APPLICATION RATES

**FIELD AND ROW CROPS:** May be applied pre-plant, side dress, fertigated, top dressed or banded to the soil. To apply alone, dilute with water to ensure uniform distribution. Use 1 to 10 gallons per acre. May be applied through center pivot irrigation systems. Repeat applications may be beneficial.

**VEGETABLE & FRUIT CROPS, ORCHARDS & VINEYARDS:** Use 1 to 10 gallons per acre. Repeat applications may be beneficial.

#### FERTIGATION APPLICATION RATES

**FIELD & ROW CROPS, ORCHARDS & VINEYARDS, VEGETABLE & FRUIT CROPS:** Use 1 to 10 gallons per acre per irrigation. Continue irrigation for a minimum of 2 hours after application to flush lines and to maximize nutrient distribution with drip and microsprinkler use. Repeat applications may be beneficial.

**APPLICATION THROUGH DRIP IRRIGATION** - inject after irrigation filter.

**TRANSPLANT WATER - FIELD & ROW CROPS, ORCHARDS & VINEYARDS, VEGETABLE & FRUIT CROPS:** Use 1 to 5 gallons per acre, not to exceed a 3% solution of **BLACKJACK Ca** to water.

#### MIXING INSTRUCTIONS

**BLACKJACK Ca** disperses well in water, but for best results, mix as follows:

1. Partially fill tank with water or fertilizer and start agitation.
2. Add other nutrients or pesticides if compatible.
3. Add **BLACKJACK Ca** to circulating tank mix.
4. Fill tank and agitate thoroughly.

#### FIRST AID

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**If swallowed:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

**STORAGE:** Store above 40°F (4.4°C). Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures. Do not contaminate water, food, or feed by storage or disposal. **DISPOSAL:** Triple rinse (or equivalent), adding rinse water to spray tank, then offer for recycling at an ACRC site (go to <http://www.acrecycle.org/> locations for) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
