Do not give anything by mouth to an unconscious person. **If inhaled:** Move person to fresh air. GENERAL INFORMATION: BlendMaster® is a formulated mixture of Choice® and surfactants for use with herbicides and pesticides which recommend the use of ammonium sulfate as a water conditioner in combination with surfactants on their labels. Water conditioning agents in BlendMaster tie-on to hard water ions (Ca⁺⁺, Mg⁺⁺ and Fe⁺⁺) to prevent interference from the hard water ions with the pesticide performance. Surfactants in BlendMaster provide uniform coverage of spray droplets.

BlendMaster can be used as an Ammonium Sulfate replacement. Some pesticides have stated use rates. The pesticide label should be consulted regarding specific use recommendations.

DIRECTIONS FOR USE

GENERAL: Fill spray tank $\frac{3}{4}$ full of water and begin agitation. Add BlendMaster at the rate of one (1) gallon per 100 gallons of water or desired rate before herbicide is added.

BlendMaster at one (1) gallon per 100 gallons of water has demonstrated performance compared to ammonium sulfate plus surfactant. One (1) pint per acre has demonstrated performance equal to two (2) pounds of dry ammonium sulfate

STORAGE AND DISPOSAL

STORAGE: Store in cool, dry place. Store in original container. Keep tightly closed.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Wastes may be disposed of on-site or an approved disposal facility. Triple rinse (or equivalent) adding water to spray tank. Offer container for recycling or dispose of container in sanitary landfill, or by other procedures approved by appropriate authorities. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
