Where crop requirements are high and the soil tests are low to very low, apply 2 to 3 lbs. per acre of boron respectively. Where the crop requirements are medium and soil tests are low to very low, apply 2 lbs. per acre of boron. Where the relative crop need is low and the soil test is very low, confirm the boron need by plant tissue analysis.

This product is intended for use in further blending with agricultural grade fertilizers and should be applied evenly. Application equipment should be calibrated to insure targeted rates of application
