FIRST AID

Ground Applications: This product may be applied by conventional ground equipment.

Aerial Applications: This product may be applied by air.

Fertigation: Product may be applied in overhead irrigations systems. Do not apply with more than 1/3 inch of water.

Drip Irrigation: This product may be injected into drip irrigation systems.

RECOMMENDATION FOR USE

Normal use rates for **Buffer Solution 0-10-0** are from 1 to 2 quarts per 100 gallons of spray solution.

The table listed below is guide only. Water high in dissolved solids or that has a significant amount of alkaline earth carbonates and/or hydroxides may require more **Buffer Solution 0-10-0** to reach the desired pH.
