### **GENERAL INFORMATION**

Calcium sprays applied to fruit before harvest may reduce the occurrence of calciumrelated disorders and improve fruit quality, especially in growing seasons following severe winters. Three to five applications of CAL-QUIK, applied at periodic intervals from early June to August, should reduce the incidence of calcium disorders. Four to seven applications may be required for severe calcium deficiency.

### **DIRECTIONS FOR USE**

Observe all usage precautions before applying CAL-QUIK.

APPLES: DILUTE APPLICATIONS: Use 2.0 pounds of CAL-QUIK per 100 gallons of water, spray to run-off (approximately 400 gallons on large mature trees).

CONCENTRATE APPLICATIONS: Use 4.0 to 10.0 pounds CAL-QUIK per acre in 35.0 to 70.0 gallons of water per acre. Begin applications 45 to 60 days after bloom.

PEARS: DILUTE APPLICATIONS: Use 1.0 pound of CAL-QUIK per 100 gallons of water, spray to run-off (approximately 400 gallons on large mature trees).

CONCENTRATE APPLICATIONS: Use 4.0 pounds CAL-QUIK per acre in 50.0 to 70.0 gallons of water per acre. Begin applications 45 to 60 days after bloom.

CHERRIES: Use same rate as pears. Apply 3 to 4 sprays of CAL-QUIK at weekly intervals just before harvest. Addition of 1.0 to 2.0 pounds of urea (use only urea formulations that contain less than 2% biuret) per 100 gallons of water may increase calcium uptake. Use the 1.0 pound rate for applications exceeding 200 gallons per acre and the 2.0 pound rate for concentrate applications. for concentrate applications.

Note: Fruit size may be reduced from calcium applications.

\*Use extreme caution and observe all USAGE PRECAUTIONS when applying CAL-QUIK on pears and cherries, as they are more likely to suffer fruit and foliage injury.

USAGE PRECAUTIONS and conditions conducive to fruit injury.

- Do not spray in cool, wet weather or when drying conditions are slow.
- Do not spray when temperatures exceed 80 °F
- Do not spray at gallonages that allow droplets to coalesce and pool on the lower part of the fruit.
- Do not spray when humidity is high or dew is present.
- Do not allow spray to overlap causing excess deposits of calcium.
- Do not spray at intervals shorter than 10 days.
- As the number of sprays applied during the season increases, risk
- Be very cautious mixing CAL-QUIK with other pesticides or nutrient sprays. (CAL-QUIK is a limited compatibility material.)
- Do not add surfactants.

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.

Do not contaminate water, food, or feed by storage or disposal. DISPOSAL: Do not reuse container. Triple rinse (or equivalent), adding rinse water to spray tank, then offer for recycling at an ACRC site (go to http://www.acrecycle.org/ locations for) or by reconditioning, or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
