CATEGORY 5 will help ensure uniformity of moisture and depth of moisture infiltration and CATEGORY 5, when used according to label rates, is safe to turf. CATEGORY 5 has not burned turf when applied according to label directions.

**DIRECTIONS FOR USE:** *Greens, Tees, Fairways, Lawns, Parks and Sports Turf Water Repellency And Poor Infiltration Conditions on Turf:* Apply CATEGORY 5 at a rate of 1.5 to 2.5 ounces per 1,000 square feet every 30 days or as needed.
