FIRST AID

GENERAL INFORMATION

Chaser LQ® contains protein hydrolysate obtained from the hydrolysis of protein to amino acids and short polypeptides that are a source of nitrogen. Chaser LQ is only for use in combination with water-soluble plant nutritional products that are formulated for foliar, sidedress or drip irrigation application.

Recommended Usage Rates when blended with fertilizer:

Tree and Fruit Crops: 8 to 16 fl oz/acre
Vegetable Crops: 4 to 8 fl oz/acre, weekly
All Other Crops: 8 to 16 fl oz/acre

Chaser LQ is believed to be compatible with most agricultural water-soluble plant nutritional products. If physical compatibility with another fertilizer is unknown, use a jar compatibility test.

FORMULATION USE PRODUCT: This product is to be used only in combination with other fertilizers.

STORAGE AND DISPOSAL

STORAGE: Store in original containers only. Keep containers tightly closed when not in use. Store in a cool, dry well-ventilated area, preferably in a locked storage area away from children, feed and food products, and seed. Store at ambient temperatures.
