#### **GENERAL INFORMATION**

**Chemsurf 80** is a general purpose surfactant and humectant for use with insecticides, fungicides, herbicides, acaracides, defoliants, dessicants, PGR's and nutritionals. The surface-active agents in **Chemsurf 80** are designed to improve wetting, spreading and humectancy of agricultural sprays on leaf, stem or insect surfaces. It also contains a defoamer that helps suppress spray tank foaming. **Chemsurf 80** is suitable for use where the pesticide label recommends a non-ionic surfactant, spreader or wetter.

# **DIRECTIONS FOR USE**

**Ground, Air, CDA**: 0.5 to 4 pints per 100 gallons of spray solution. Use enough ChemSurf 80 to achieve good wetting, spreading and surface coverage without excessive run-off.

The above recommendations are adequate for most uses. However, some pesticides may require different adjuvant rates. When this occurs, follow the pesticide label directions. Environmental conditions, equipment condition, crop health, pest infestation levels, and the accurate operation of spray machinery can influence the effects of the pesticide and the spray application itself. Therefore, it is recommended that adjuvant concentrations be adjusted based on careful observation of spray deposits.

### **MIXING INSTRUCTIONS**

Fill spray tank one-half full and start agitation. Always follow pesticide label directions for proper mixing order, or if no specific mixing order is indicated on the pesticide label use the following sequence:

- 1. Dry flowables, water dispersible granules
- 2. Wettable powders
- 3. Flowables
- 4. Aqueous solutions
- 5. Emulsifiable concentrates
- 6. Add Chemsurf 80 last and continue agitation

## STORAGE AND DISPOSAL

**Storage:** Store in a cool. dry place. Store only in the original container. Do not store near feed or food.

Disposal: Triple rinse container and offer for recycling/reconditioning or dispose of at an approved sanitary landfill. DO NOT REUSE EMPTY CONTAINER.
