*Chemurgic's Next Gen Spreader*, an alcohol ethoxylate formulation, is a general purpose non-ionic surfactant (NIS) of the alkyl polyethoxyethanol type surface active agents. This product does not contain Nonylphenol Ethoxylates (NPEs). Also an anti-foam has been added to handle the high foaming associated with some product combinations. It can be used with most insecticides, fungicides, herbicides, acaricides, defoliants, desiccants, plant growth regulators (PGR) and wettable powders to improve performance of the active spray ingredient by giving them more uniform distribution and better wetting of the plant surface.

**MIXING INSTRUCTIONS** For wettable powders and water-soluble materials, add this product in water before adding pesticide to spray tank. For emulsifiable products, add this product after a good emulsion is formed.
